## **FOR OWNER-OCCUPANTS AGE 65 AS OF MAY 1<sup>st</sup> OR OWNER-OCCUPANTS RECEIVING SUPPLEMENTAL SECURITY INCOME FOR A DISABILITY OR RECEIVING SECURITY DISABILITY INSURANCE BENEFITS**

Under the provisions of the Parcel Tax approved by voters: Homeowners who attain 65 years of age, individuals receiving Supplemental Security Income for a Disability, or individuals receiving Social Security Disability Insurance Benefits by May 1<sup>st</sup> of any year, may request an exemption from the parcel tax for the following tax year. To qualify, you must both own and reside at the property for which the exemption is requested.

### **Filing date for the exemption to take place for any year is May 1<sup>st</sup>.**

#### **PROOF OF ELIGIBILITY: (MUST BE INCLUDED WITH APPLICATION)**

1. **Proof of Ownership:** Attach a copy of your current Property Tax Bill indicating your ownership of the property.
2. **Verification of Age:** Attach a copy of a valid Driver's License or California Identification Card or passport.
3. **Proof of Occupancy:** If your Driver's License or California Identification Card or passport has an address other than that which you are requesting the exemption, attach a copy of a current Utility Bill (PG&E or Water) with address intact.

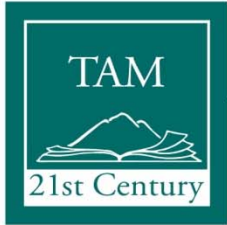
#### **If you are applying for the exemption due to the owner-occupant receiving Supplemental Security Income for a Disability or Security Disability Insurance Benefits:**

4. Attach a copy of your Benefits Verification Letter. This can be obtained by visiting your local Social Security Administration Office at 1001 Loutens Place, 3rd Floor, San Rafael or calling 1-800-772-1213. (\*Not required for a senior exemption).
