**WHEREAS**, due to lack of work and/or lack of funds in the Tamalpais Union High School District, the Board of Trustees, under the authority of Education Code section 45114, 45115, 45117, 45298, and 45308, hereby finds it necessary and in the best interest of the District to eliminate the full-time equivalent (FTE) of the classified services as specified below:

Grounds Person	1.0 (8 hours/day per FTE)
Community Education Program Assistants	3.0 FTE total Tamalpais HS: 5 hours/day; 4 days/wk. Drake HS: 5 hours/day; 4 days/wk. Redwood HS: 2.75 hours/day; 4days/wk.
Community Education Secretary	0.5 (8 hours/day)
Food Service Worker	2.0 (2 to 8 hours/day per FTE)
Food Service Cook	0.5 (8 hours/day)
Clerk IV	3.0 (5 hours/day per FTE)
Custodians	2.0 (4 hours/day per FTE)

**NOW, THEREFORE, BE IT RESOLVED**, that as of June 30, 2019, the classified positions set forth above shall be discontinued to the extent herein above set forth.


