Parcel Tax Measure Oversight Committee Application Information

What is the Parcel Tax Measure Oversight Committee?

On November 6, 2018, the voters of the Tamalpais Union High School District approved Measure J, which authorized the District to levy an annual parcel tax of \$149 per parcel for four years. Measure J required the District's Board of Trustees to appoint an independent citizens' oversight committee. The Parcel Tax Measure Oversight Committee was designated as the oversight committee for Measure J.

What does the Committee do?

The purpose of the Committee is to inform the public concerning the expenditure and uses of revenues from Measure J. The Committee's purpose is an audit function rather than an advisory function. The Committee's charge is to actively review and report on the expenditure of parcel tax proceeds and to ensure said revenue is expended in accordance with the purposes stated in Measure J.

How are Committee members appointed?

Interested Committee members should complete and return an application. Committee members are selected by the Board by majority vote. The Board may form a subcommittee to review applications. Members are appointed for three years terms.
